Adult Slow Pitch Softball Rules & Policies

- 1. Games will be played on Wednesday evenings beginning mid-August.
- 2. Players must be at least eighteen (18) years of age to participate in the adult softball program.
- 3. Participants must always wear a shirt and shoes. No sandals or metal cleats are allowed.
- 4. Exposed jewelry of any kind is not allowed.
- 5. Participants will register as a team. Each team member must have a signed waiver/release.
- 6. Games will be played with 10 defensive players on the field. May play with as few as 8.
- 7. Coed teams must include 5 women and 5 men playing defense (a 5w/4m or 4w/4m combination are the only other combinations permissible when teams have less than 10 players).
- 8. A continuous batting order of all players present must be used.
- 9. Batting order must alternate genders.
- 10. Men will hit 12" softballs, women will hit 11" softballs.
- 11. There are no defensive position restrictions, anyone can play any position.
- 12. Substitutions are permissible by gender only, both offensively and defensively.
- 13. Unlimited substitutions on defense are allowed.
- 14. Base distance will be 65 feet.
- 15. Pitching distance will be 50 feet.
- 16. Batters will start with a 1-1 count.
- 17. There will be no courtesy foul ball. A foul ball hit on a third strike is an out.
- 18. No bunting is allowed, must be a full swing.
- 19. No leading off, runner may not leave base until pitch reaches the plate.
- 20. No stealing is allowed.
- 21. Outfielders must stay in the grass until the ball is hit. If violated, batter will be awarded a single and any other runners forced to advance will move up one base or the result of the play, whichever is most advantageous.
- 22. A walk to a male batter (whether intentional or not) will result in a two base award and the following female must bat if less than two outs. With two outs, the following female batter has her choice of batting or receiving an automatic walk.
- 23. Pinch runners are only allowed in case of injury and must be the last batted out of the same gender.
- 24. Pitchers are allowed a maximum of three warm up pitches within one minute before each half inning.

- 25. Pitchers must be on the rubber at time of release and speed of pitch must be slow.
- 26. Pitches must be delivered with a perceptible arc and reach a height of at least 6 feet while not exceeding a height of 10 feet from the ground.
- 27. The strike zone is the space directly above home plate that is no lower than the batter's front knee and no higher than the batter's back shoulder.
- 28. Games are 7 innings or 60 minutes long. No new inning may begin with 5 minutes or less remaining.
- 29. Games that are tied at the end of 7 innings or time limit will play ONE tied breaker inning with the last batted starting on second base.
- 30. Run rules: 20 after 3, 15 after 4, and 10 after 5 innings.
- 31. Teams are limited to 2 over the fence home runs per game. After 2, any ball hit over the fence is an out.
- 32. A ball that bounces over the fence is a double.
- 33. Teams may get matching team shirts and/or have a team sponsor. Team shirts are not required and will not be provided by Parks & Rec.
- 34. Each team will receive two (2) 12" softballs and two (2) 11" softballs with a COR rating of .52 and ball compression of 300 lbs at the beginning of the season to use for games and practices. Each team is responsible for providing the balls they use at bat. The team at bat is responsible for getting another ball to the umpire if it is hit out of play. Any additional balls provided by the teams must adhere to above COR and compression standards.
- 35. Teams are responsible for all other equipment including bats and safety gear if desired. Batting helmets and catcher's/pitcher's masks are strongly recommended.
- 36. Any unaltered, stamped, legal/non-banned bat except senior and ultra bats are allowed. The umpires will know if your bat is allowed.
- 37. Smoking and alcohol are not permitted on any City property including ball fields, dugouts, bleachers, etc. before, during, or after games. Pick up all trash!

PLAYER/TEAM CONDUCT

- Only the team manager or designated player will be allowed to communicate with the umpire.
 Other players who communicate with the umpire will be warned by the umpire (team warning through manager) first, and then ejected from the game after another occurrence.
- Undue harassment of the official(s) before, during, or after the game may result in the ejection of the individual(s) involved. Any player, coach, or fan who is ejected from the game and reported to the Program Manager by an official or department representative will be removed from the program.
- After an ejection, the individual ejected must immediately leave the field and spectator area.
 Failure to do so or continued harassment of the official may lead to forfeiture of the game by that player's team and notification to authorities.
- Any player who strikes, attempts to strike, or verbally threatens an official; who fights with
 another player; or who is ejected for unsportsmanlike behavior will be removed from any and all
 teams on which that individual plays. This suspension is for one calendar year and includes all
 teams and sports in which that person plays.
- Any team members, who are found drinking in the playing areas (field, dugouts, coaching boxes, etc.) will result in a team suspension for one game. If this occurs a second time, the team will be suspended for the remainder of the season without refund.
